Saturday 25 September to Sunday 3 October 2021 6.00am to 8.00pm
No personnel permitted at the Barracks after these times.

Drivers will require an Irwin Barracks parking pass which will be posted to you. The parking pass will need to be displayed on the driver's side dashboard of the vehicle that has been registered. Vehicles without parking passes will not be admitted into the Barracks. Drivers must ensure that on arrival at the Barracks they have a valid Driver's Licence to present to gate staff.

Please park in the allocated area and wait for the shuttle bus to collect you. Personnel are not allowed on base on foot.

To enable adequate parking space to be allocated and to facilitate the preparation of security arrangements and passes, persons considering taking advantage of these parking arrangements **must** complete this form and return no later than **MONDAY 6 SEPTEMBER 2021** by email to the relevant Competition and Event Coordinator.
